National Epidemiological Surveillance System. SIVEI

It is aimed at health personnel (professionals working in public and private establishments that must carry out mandatory notification, personnel from the different levels of the Ministry of Health) who carry out epidemiological surveillance management.

The system includes notification of group A, B and C or Collective B events, laboratory tests of notifiable events and reporting of negative events indicated in Health Surveillance Regulation 40.556-S

This system allows to have the mandatory notification process through the official country platform, identifying each of the notifiers and allowing the information of these events with the required opportunity for the necessary interventions and from there towards the decision making that is required at the different levels of management.

- **Article 21° - Establishment of the National System of Automated Health Surveillance.**

The National Automated Health Surveillance System (SINAVISA) is made up of the components of the National Health Surveillance System that are available for electronic reporting or admission, among which are malignant tumors, vaccines applied or immediate notification events corresponding to group A of the events that are subsequently defined in this same regulation. This system will be available 24 hours a day, seven days a week, and will allow in many of the most important events that anyone who must make reports on mandatory notification events does so in real time, via the web. For entry into this system for those responsible for defined notifications within the health sector, they will be assigned prior to basic training in their use, users and passwords by the Health Surveillance Directorate.



- **Article 32: The obligation to deliver information to the Ministry of Health.**

The public and private entities of the country that provide health services to people as well as all persons and

public and private organizations that produce, manipulate or concentrate information that is related to the health events included in this decree and its determinants, as well as any unforeseen or un event that may affect human health, must notify them in a timely manner, as well as any other information required by the Ministry of Health, the country's governing body in Health through its different levels of management (article No.5 of the General Health Law).

Failure to comply with the foregoing compromises the authorization permit, an essential requirement to function as a health establishment.

For the purposes of mandatory notification of health events in SIVEI, all events classified in **Article 37 - Notifiable health events are contemplated: Group A, Group b and Group C.**
